To complete your W-8BEN form, simply:

1. FILL OUT, SIGN, AND DATE THE W-8BEN ON THE PAGES THAT FOLLOW

a) A foreign tax identification number must be provided in line 6 of Part I.

2. A CURRENT COPY OF YOUR PASSPORT IS REQUIRED

- If you do not have a passport, please provide a copy of a government-issued ID that indicates your citizenship. A driver's license is not acceptable.
- b) If the date of issuance of your passport or other ID is more than three years ago, please also provide a recent copy of a utility bill or bank statement that verifies the address you provided on the form.
- c) If your country of citizenship is different than your country of residence, (Example: Citizen of France living in Spain) please also provide a **signed original** letter explaining why they are different, a copy of your passport, and a utility bill as proof of residence.
